REACH Statement for Polyethylene Bralen®, Bralen+® and Polypropylene Tatren®

SLOVNAFT, a.s. company as a producer and supplier of all above mentioned polymers in a compliance with the regulatory system EC 1907/2006 for Registration, Evaluation, Authorization and Restriction of Chemicals (REACH) with the principles of registration grades gives the following statement:

1. The obligation to register substances polyethylene and polypropylene

- **Polyethylene** low density (CAS 9002-88-4) according to the „TITLE I, Article 2(9)“ of the REACH Regulation EC 1907/2006 as amended **is not the subject to registration**, but the monomer – Ethylene, from which the polymer is produced, is registered in a compliance with REACH
- **Polypropylene homopolymers** (CAS 9003-07-0) and **Polypropylene copolymers** (CAS 9010-79-1) according to the „TITLE I, Article 2(9)“ of the REACH Regulation EC 1907/2006 as amended **are not the subject to registration**, but the monomers from which they are produce should be registered in a compliance with REACH
- **Ethylene** (CAS 74-85-1) manufactured and used by SLOVNAFT, a.s. for the production of polyethylene and polypropylene **was registered** with registration number: 01-2119462827-27 by November 30, 2010
- **Propylene** (CAS115-7-1) manufactured and used by SLOVNAFT, a.s. for the production of polypropylene **was registered** with registration number: 01-2119447103-50 by November 30, 2010
- **All additives** used in the manufacturing of all above mentioned polymers **are registered** by their's suppliers in accordance with REACH

According to the „TITLE I, Article 2 (9)“ of the REACH Regulation EC 1907/2006 as amended the polymers are not subject of registration the manufacture according to Article 10 to 14 is not obliged.

- **to create registration dossier**
- **to create exposition scenario and chemical safety report**

2. The presence of hazardous substances

All above mentioned polymers are not classified according to Regulation 1272/2008/EC - CLP as dangerous and containing neither ingredients dangerous for health nor for the environment.

3 The statement to the presence of substances Dimethylfumarate (DMF)

We confirm that SLOVNAFT, a.s. fulfills the conditions of Decision 2009/251/EC of the European Commission and that the substance of Dimethylfumarate (DMF) does not occur in all our products / substances and even product packaging. The nature of the production technology of processing crude oil and petroleum products shows that this compound is not present in our products.

4 The biocides presence in substances polyethylene and polypropylene.
